## **Exhibitor Rules and Regulations**

Exhibitors must display and sell only the items they submitted and approved by the committee. Photos of work and display submitted to the committee will not be returned unless you come to the office to retrieve them.

Once the exhibitors enter the park, they will be directed to the exhibit area and their particular space(s). All spaces will be pre-assigned.

**Set Up Times:** 7:00 a.m. to 9:00 a.m., Saturday, April 22, 2023

**Show Hours:** 10:00 a.m. to 3:00 p.m., Saturday, April 22, 2023

**Break Down Times:** Early break down will not be permitted. Participants must leave their exhibit set up for the length of the show

**All vehicles must be removed from the exhibit area by 9:00 a.m.** In order to keep the area from getting congested, we are requesting that exhibitors drop off their display and merchandise and park their vehicle prior to setting up their display. Vehicles are not permitted on the actual fairground area during show hours for any purpose.

Exhibitors will be erecting their displays on a grass field. All racks, tents, canopies and other displays must be securely weighted or staked down. All precautions should be taken to ensure safety in windy conditions. Exhibitors must furnish their own tables and chairs. All tables must be skirted.

No merchandise storage outside of exhibit booth is allowed.

**There is no rain date or refunds of application fee once accepted.**

Exhibitors must maintain the cleanliness and orderliness of their booths at all times, reflecting the proper decorum of a fine show. No improper behavior, offensive language or loud music is permitted.

Exhibitors must dispose of their trash in proper receptacles throughout the day and are encouraged to be "litter free" limiting the use of plastics and excessive garbage. Please use environmentally friendly items for packing, etc. We STRONGLY discourage the use of Styrofoam.
